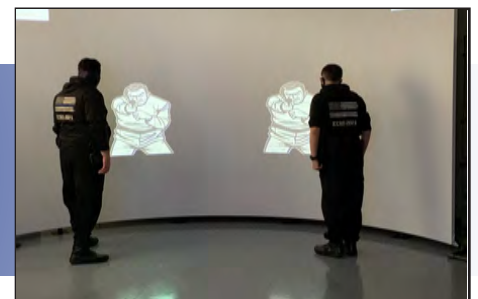
BACKGROUND

The Academy of Law & Public Safety (ALPS) is one of the career academies administered by the Ocean County Vocational Technical School District. The shared-time Law & Public Safety program was established in 2001, offering a unique and comprehensive foundation of skills for Ocean County students interested in pursuing a career in law and public safety. The 2015-16 school year launched the Academy of Law & Public Safety as a full-time rigorous, college-preparatory educational program for high school juniors and seniors, providing a challenging, hands-on learning experience for college-bound and career-oriented students. As of September 2018 ALPS is now a full-time, four-year high school academy.

The academy is located in Waretown, New Jersey. The Ocean County Vocational Technical School District is responsible for recruitment, admissions, and the instructional program. The Academy of Law & Public Safety selects its students from applicants found within the public and private high schools of Ocean County.

ACCORDING TO RECORDS SINCE 2008:
452 students graduated from the program
392 (87%) have gone on to college
41 (9%) have gone on to military

Law & Public Safety graduates have been hired and/or are currently employed with over 30 New Jersey Police Departments, as well as New Jersey Departments of Correction, the Ocean County Sheriff's Office, the Ocean County Prosecutor's Office, the New Jersey Administrative Office of the Courts and the New York State Police.





APPLICATION PROCEDURES

APPLICATION PROCEDURES

1. You may apply to only one academy. You may attend as many information sessions as you like to help you decide which school is right for you.
2. Academy applications and admission materials can be accessed by attending one of the information sessions.
3. Complete the required application online. 7th grade final report card and 8th grade first marking period report card **MUST** be included and will be requested from students' home school.
4. **All applications MUST be submitted online by midnight on December 11, 2024.**
5. Take the admissions test on January 25, 2025. Testing details to be determined.

FREQUENTLY ASKED QUESTIONS

Q. What must be included with my application?

A. The application must be completely filled out. Grade transcripts compiled from 7th grade and the first marking period of 8th grade will be requested from the students' home school. The deadline for applications will be December 11, 2024. It is the applicant's responsibility to make sure that the application is submitted on or before the deadline. Late applications WILL NOT be accepted.

Q. How competitive is the admissions process?

A. In general, there will be more applicants than available space. We assign scores to all applicants based on academic records and performance on our entrance exam.

Q. What happens if I am not accepted?

A. If you are not accepted but you meet the minimum criteria, your application will remain on file. Should an opening occur, your application may be reconsidered.

Q. What is on the entrance exam?

A. The exam contains two sections: mathematics and language arts literacy. Questions are multiple-choice.

Q. What if I am sick and miss the exam?

A. A make-up date will be available for the exam, based on the circumstances of the individual.

Q. How and when will I be notified of acceptance?

A. It will take approximately four weeks for all processing to be completed after the testing date. All applicants who have completed the admissions process will be notified by mail whether they have been accepted or not.

Q. Can I apply to more than one Career Academy?

A. No, you may only apply to one school. The Career Academies offer very specialized curricula. The Career Academies admissions process attempts to match students to the most appropriate program for that student. One of the first steps in that process is for you to choose the school that most fulfills your interests and abilities.

Q. How will I make arrangements for transportation and other costs?

A. The Ocean County Vocational Technical School District is a public school district. If you have been accepted, your resident school district will be notified and transportation will be provided by that district. You can expect to incur the same kinds of costs that you would in your resident school. Notebooks, pens, pencils, etc. are your responsibility to provide.

Interested 8th grade students may apply this year to be part of the incoming freshman class in September 2022). Students are accepted through a competitive application process. All courses are instructed utilizing a block schedule format - classes are 80 minutes.

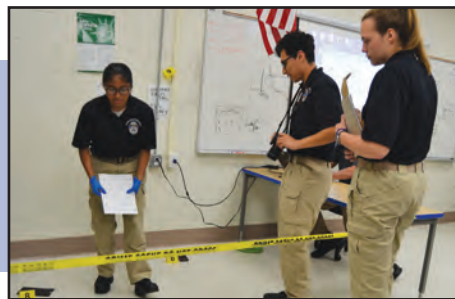
